The committee annually reviews compensation data from outside sources, such as national data from GuideStar and state data from the Ohio Association of Non-Profit Organizations (OANO), as well as the Ohio Department of Job and Family Services labor market index. The committee does this review independent of the executive director and makes a report and recommendation to the full board in executive session without the participation of the executive director. Upon the approval of the full board, the employment agreement is amended accordingly, and the compensation is adjusted as indicated for the following year.
